SALES UPDATE FOR THE TEN MONTHS ENDED 31 OCTOBER 2017

This announcement is made by **Jiayuan International Group Limited** (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Company wishes to provide its shareholders and potential investors with a sales update containing certain operating data of the Group for the ten months ended 31 October 2017 (the “**Sales Update**”).

For the period from 1 October 2017 to 31 October 2017, (i) the contracted sales of the Group was approximately RMB404.5 million; (ii) the corresponding gross floor area sold was approximately 31,117 sq.m.; and (iii) the contracted average selling price was approximately RMB 12,998 per sq.m..

For the ten months ended 31 October 2017, (i) the contracted sales of the Group was approximately RMB5,605.8 million; (ii) the corresponding gross floor area sold was approximately 645,790 sq.m.; and (iii) the contracted average selling price was approximately RMB8,680 per sq.m..

The Sales Update has been prepared based on internal management records of the Group, which has not been audited nor reviewed by the external auditors, and accordingly, the operating data contained therein is for investors' information purpose only and may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-year basis due to various uncertainties during the process of collection and collating of such operating data.
