SALES UPDATE

FOR THE TWO MONTHS ENDED 28 FEBRUARY 2019

This announcement is made by **Jiayuan International Group Limited** (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Company wishes to provide its shareholders and potential investors with a sales update containing certain operating data of the Group for the two months ended 28 February 2019 (the “**Sales Update**”).

For the period from 1 February 2019 to 28 February 2019, (i) the contracted sales of the Group was approximately RMB1,046.7 million, representing a year-on-year increase of approximately 63%; (ii) the corresponding gross floor area sold was approximately 100,397 sq.m, representing a year-on-year increase of approximately 43%; and (iii) the contracted average selling price was approximately RMB10,426 per sq.m., representing a year-on-year increase of approximately 14%.

For the two months ended 28 February 2019, (i) the contracted sales of the Group was approximately RMB2,094.9 million, representing a year-on-year increase of approximately 88%; (ii) the corresponding gross floor area sold was approximately 190,725 sq.m. representing a year-on-year increase of approximately 60%; and (iii) the contracted average selling price was approximately RMB10,984 per sq.m., representing a year-on-year increase of approximately 18%.

The Sales Update has been prepared based on internal management records of the Group, which has not been audited nor reviewed by the external auditors, and accordingly, the operating data contained therein is for investors' information purpose only and may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-year basis due to various uncertainties during the process of collection and collating of such operating data. The Sales Update does not constitute, nor should it be construed as, an offer or solicitation for the purchase or sale of any securities of the Company.
